
ABOUT THE PROJECT?

In March 2019, ADNOC signed an agreement with UBPL, granting a 100% exploration stake in the Onshore Block 1 Concession to explore, appraise and develop the concession area's hydrocarbon resources. This UBPL-operated exploration concession has the potential to play an important role to ensure a sustainable and economic oil and gas supply to the UAE, for the benefit of the country and its people.

WHAT IS EXPLORATION AND APPRAISAL DRILLING

Exploration drilling consists of drilling a well to confirm the presence of oil and gas. Appraisal drilling consists of drilling a well to determine the size and the extent of the oil and gas field. The primary objective of this partnership is to evaluate oil and gas resources in the Onshore Block 1 concession area.

LOCATION AND UPCOMING ACTIVITIES



Before drilling activities begin, drilling and accommodation equipment will be moved to the well location, as indicated by the yellow dot on the map. The yellow arrows indicate the equipment transportation route. During site set up, there will be an increase in road traffic.

The drilling of the exploratory well (XN-78) will involve site preparation activities including the development of a temporary access road from Qif Rashid Road. In the drilling phase, a well hole is drilled into the earth and lined with pipes, to reach the oil and gas reservoir. This is followed by well testing, a process of understanding the potentials of the reservoir, during this time you may see some planned flaring.

The results of these tests will decide the timeline of activities. If no viable outcomes, the site will be closed and restored in November 2022, however, if there is a positive appraisal which shows the presence of substantial oil and gas resources, further appraisal activities will continue into 2024.

OPERATIONAL IMPACTS

We are committed to minimizing the impact of our activities on surrounding communities and mitigate against any potential disruption. However, when conducting operations, you may experience or see an increase in:

Traffic: Increased road traffic during the day only

Noise: A potential noise disturbance from site set up and normal drilling operations

Smell: A slight hydrocarbon smell, like gasoline

Flaring: Safely controlled burning of hydrocarbons

Light: Bright night lighting at the well site
